Terms and Conditions

All applicants please read the conditions below, indicate the preferred time of induction and then turn over and COMPLETE THE MEDICAL QUESTIONNAIRE.

1. Good gym etiquette is expected from all gym members.
2. All members must sign in prior to using the facility.
3. Only gym members are allowed to use the facility without the express consent of Full Circle Training. You must pay the amount due at the end of your membership term for renewal to be eligible to use the facility.
4. Lockers are provided for all gym members. No gym bags or other personal belongings are allowed in the Fitness Area. Lockers must be cleared out each day. Full Circle Training reserves the right to remove a lock and the contents each locker at the end of each day.
5. Full Circle Training is not responsible for lost or stolen items.
6. No food is allowed in the Fitness Area. Outside drinks must be in a plastic bottle or container to be taken onto the gym floor
7. Please bring a hand towel for your own hygiene.
8. Please follow any and all posted gym rules.
9. You may be photographed or videotaped during your time at this facility. By signing below, the member agrees for their picture to be used in any kind of gym/club/trainer promotion.

(Waiver and Release of Liability)

The club urges you and all members to obtain a physical examination from a doctor before using any exercise equipment or participating in any exercise classes. All exercises, including the use of free weights and use of any and all machinery, equipment, and apparatus designed for exercising shall be at the member's sole risk. Member understands that the agreement to use, or selection of exercise programs, methods and types of equipment shall be member's entire responsibility, and the Club shall not be liable to member for any claims, demands, injuries, damages, or actions arising due to injury to member's person or property arising out of or in connection with the use by member of the services, facilities, and premises of the Club. Member hereby holds the Club, its officers, owners, agents, and employees harmless from all claims which may be brought against them by member or on member's behalf for any such injuries or claims.

If by reason of death or permanent disability, the buyer is unable to continue the membership, buyer or buyer's estate shall be relieved from the obligations of this contract, and if buyer has prepaid any sum, the prorated amount shall be promptly refunded. Should member permanently move their residence more than 25 miles from an affiliated area, payment on this agreement will be suspended upon payment of an appropriate cancellation fee of \$50.00 and legitimate verification of the move. Member agrees to follow club rules as promulgated from time to time. Violation of these rules may be the cause for suspension of cancellation of membership.

ANY HOLDER OF THIS CONSUMER CREDIT CONTRACT IS SUBJECT TO ALL CLAIMS AND DEFENSES WHICH THE BUYER/MEMBER COULD ASSERT AGAINST THE CLUB AS A RESULT OF THIS CONTRACT. RECOVERY BY THE BUYER/MEMBER SHALL NOT EXCEED THE TOTAL AMOUNT PAID BY THE BUYER/MEMBER TO THE CLUB PURSUANT TO THIS CONTRACT. YOU THE BUYER MAY CANCEL THIS AGREEMENT BY MIDNIGHT OF CLUB'S THIRD BUSINESS DAY AFTER THE DATE OF THIS AGREEMENT, AND SUCH CANCELLATION MUST BE IN WRITING TO THE CLUB. IN THE EVENT THE CLUB CLOSES AND CEASES DOING BUSINESS, YOU ARE NO LONGER OBLIGATED TO MAKE PAYMENTS UNDER THIS AGREEMENT.
